#### -5/16/19 Meeting Minutes Approved

  - Include a picture of Gazebo. John volunteered to look at the gazebo and make a recommendation on current condition and if it's possible for a volunteer work party to complete the work.
  - o Include a reminder of the Annual Meeting.
  - o Include Highlights from the past year.
- Sarah volunteered to distribute the newsletter. Kim offered up a couple dates that she could help.
- Action Items: John look at gazebo and email Sarah recommendation. Sarah write up newsletter. Sarah and possibly Kim distribute newsletter.

#### -Website

- Add all board meeting minutes to website.
- Action Item: Becky add minutes to website.

#### -Attorney

- Our attorney, Mary Ann Strickler has retired.
  - o Her office sent a letter with several recommendations for new representation.
  - John strongly urged the board to find a new attorney and discuss with them our current issues (such as sidewalk issues).

- o Kim will set up a meeting. Becky volunteered to attend with Kim if needed.
- Action Item: Kim set up a meeting with possible new attorney.

#### -Sidewalk/ Tree Removal

- Two trees were removed this summer. One due to storm damage, the second was next in line on the tree plan.
- One tree will be planted this fall. The homeowner replaced their sidewalk and requested a replacement tree.
- John mentioned raising money to complete the needed work through an assessment.
  - Research would need to be conducted to determine how much money would be needed to complete the necessary work.
  - Kim is concerned that this would be a hardship on many families in our community.

## - Budget

- John had two questions for Fran regarding the budget sheets listed on the website.
  - Why is there a spike in the water bill in the summer? Fran explained that the irrigation system is turned on in the summer. Fran has is shut off during the Fall/Winter months.
  - Why were there legal fees charged last year? Fran explained that a couple events last year resulted in legal fees.

# -Member-at-Large Board Position

- Chuck Burt has moved from the neighborhood, leaving the Member-at-Large position open.
- Fran nominated John Erwin for the position
  - Kim questioned what the CC&Rs say about electing a new board member
- Note: After the meeting Kim investigated the By-Laws and found the following regarding vacancies on the board:
  - At a regular meeting not less than 30 days preceding the annual meeting, the Board shall appoint a Nominating Committee of at least three (3) members. (a)The Nominating Committee shall present to the annual meeting a slate of one or more nominees for each directorship. (b)Nominations may also be made from the floor. (c)Before making a nomination, members, as well as the Nominating Committee, shall obtain the consent of the member to be nominated.
